Greetings to All !

As the financial year 2016-17 is nearing, the government has directed the municipal commissioners to put in serious efforts to achieve 100 percent collection of property tax by March 31 without fail.

Since there is a lot of encroachments and unauthorized layouts raise in recent days, to manage the city system Anantapur Corporation is focusing on eradication of unauthorized layouts and encroachments. We also creating awareness among people by advertising the pros and cons of unauthorized layouts/encroachments.

The NTR Barosa pension scheme, started with an aim to improve the living status of poor people in Andhra pradesh is being monitored effectively and steps were taken such that the scheme benefits all the eligible people in the ULB.

The Smart Pulse Survey launched on July 8th across Andhra Pradesh with an objective to ascertain the socio-economic status of people is being carried efficiently in the ULB with over 107 enumerators working on it. 83.25% of total population has been surveyed till March 31, 2017.

## State Programmes

### Pension Distribution – NTR Bharosa Pension Scheme

In order to fulfill the AP state poor people minimum needs, state government introduced NTR Bharosa Pension Scheme. Under this scheme, the state government of Andhra Pradesh provides financial aid by the name of pension to the poor and elderly people who are all the resident of Andhra Pradesh. In order to make this scheme as an effective one, the state government announced certain criteria by which the eligible people will be sorted. Old Age Pension, Weavers Pension, Widow Pension, Disabled Pension, Toddy Tappers are the types of pension covered under the scheme.

Hon'ble Mayor M.Swaroopaa has inspected the progress of pension distribution through NTR Bharosa Pension in Anantapur Municipal Corporation. She has instructed the staff to cover all the eligible people through the scheme and provide direct pension distribution rather than online for the people who are illeterates.



### Smart pulse Survey

The Smart Pulse Survey launched on July 8th across the state with an objective to ascertain the socio-economic status of people, is being carried effectively in the ULB. As many as 107 enumerators were conducting survey covering all 50 wards in the town. 83.25% of the households have been surveyed in the Anantapur Municipal Corporation by the end of March 2017.

## Property Tax Collection

Property tax and non-taxes constitute major revenue sources of the municipalities and municipal corporations. As the financial year 2016-17 is nearing, the corporation has directed the municipal staff to put in serious efforts to achieve 100 percent collection of property tax and other non-taxes by March 31 without failing. Instructions were given to Municipal Staff to serve Red Notices to defaulters. Mayor held a meeting with Town Planning, Engineering, Sanitation and Revenue Department and has ordered them to update the progress of tax collection on daily basis. She has also instructed to increase the publicity on tax payment through Auto and advertisement in local Channels.
